ESA PAYMENT INFORMATION

Tiny School, Big Hearts Academy is an approved Arizona Empowerment Scholarship Account (ESA) vendor.

- ESA funds are distributed by the State of Arizona on a quarterly basis.
- Families are responsible for submitting payments through ClassWallet.
- Delays in ESA funding do not eliminate the family's obligation to make tuition payments.
- Any ClassWallet processing fees are the responsibility of the family.
- If ESA funds are delayed, denied, suspended, or insufficient, the Parent/Guardian remains responsible for all tuition balances owed.

PAYMENT POLICIES

The Parent/Guardian understands and agrees that:

Tuition Due Dates

- Tuition is due on the 1st day of each month.
- A five (5) day grace period will be provided.

Late Fees

- A late fee of \$25 per day will be assessed beginning on the 6th day of the month if payment has not been received.

Delinquent Accounts

- Student attendance may be paused if tuition remains unpaid after the 10th day of the month.
- Enrollment may be terminated if tuition remains unpaid for more than two (2) weeks.

Returned Payments

- Any fees incurred due to returned or declined payments are the responsibility of the Parent/Guardian.

EXTENDED CARE AGREEMENT

Extended Care is optional and billed separately from tuition.

Rates

- Daily Rate: \$15 per day
- Monthly Rate: \$100 per month

- Extended Care fees are not covered through ESA funding.
 - Extended Care fees must be paid privately.
 - Space is limited and may not always be available.

STUDENT SUPPORT SERVICES

Tiny School, Big Hearts Academy strives to meet the needs of all learners.

- Enrollment and support services are reviewed individually.
 - Specialized staffing, services, accommodations, or individualized support beyond the standard educational program may result in additional tuition or service fees.
 - The Academy reserves the right to determine whether it can appropriately meet a student's educational, behavioral, medical, or support needs within the microschool setting.

WITHDRAWAL POLICY

- A minimum two (2) week written notice is required before withdrawal.
- Tuition remains due during the two-week notice period.
- No tuition refunds will be issued for partial months attended unless otherwise approved by administration.
- Any tuition payments made prior to the student's first day of attendance may be refunded, excluding any non-refundable enrollment deposit.
- Enrollment deposits are non-refundable and reserve the student's placement for the school year.

KINDERGARTEN ENROLLMENT LIMITATION

To maintain the individualized nature of the program, Kindergarten enrollment is intentionally limited. Enrollment may close once available spaces have been filled.

PARENT/GUARDIAN ACKNOWLEDGMENT

I have read and understand the tuition, payment, ESA, extended care, withdrawal, and enrollment policies of Tiny School, Big Hearts Academy.
