PURPOSE OF THIS AGREEMENT

Tiny School, Big Hearts Academy is a home-based microschool that provides educational, enrichment, and recreational opportunities for students. Parents/Guardians acknowledge that participation in school activities involves certain inherent risks that cannot be completely eliminated.

By signing this agreement, the Parent/Guardian voluntarily permits the above-named student to participate in all school-related activities and accepts the terms outlined below.

ASSUMPTION OF RISK

The Parent/Guardian understands and acknowledges that participation in school activities may involve risks, including but not limited to:

- Slips, trips, falls, and other minor accidents
- Playground and outdoor learning activities
- Physical education, movement, and exercise activities
- Arts, crafts, science experiments, and project-based learning activities
- Use of classroom materials, tools, and equipment appropriate for student age and ability
- Student interactions and social activities
- Outdoor exploration, gardening, and nature-based learning
- Participation in field trips, special events, and enrichment activities when offered
- Exposure to common illnesses or communicable diseases

The Parent/Guardian understands that while reasonable precautions are taken to provide a safe learning environment, it is impossible to eliminate all risks associated with participation.

HOME-BASED LEARNING ENVIRONMENT ACKNOWLEDGMENT

The Parent/Guardian understands and acknowledges that Tiny School, Big Hearts Academy operates in a home-based educational setting rather than a traditional public or private school facility.

The Parent/Guardian understands that students may participate in learning activities in various indoor and outdoor areas of the property and acknowledges the unique nature of a home-based learning environment.

RELEASE OF LIABILITY

To the fullest extent permitted by Arizona law, the Parent/Guardian, on behalf of themselves and the student, releases and holds harmless Tiny School, Big Hearts Academy, its owner, employees, volunteers, agents, and representatives from any claims, demands, actions, damages, or liabilities arising from participation in school activities, except in cases of gross negligence, reckless conduct, or willful misconduct.

This release applies to ordinary risks associated with participation in educational, recreational, and enrichment activities conducted by the microschool.

MEDICAL TREATMENT AUTHORIZATION

The Parent/Guardian understands that emergency medical treatment authorization is provided separately through the school's Emergency Contact and Medical Authorization Form.

In the event of an emergency, school personnel may contact emergency medical services and follow the instructions outlined in the student's Emergency Contact and Medical Authorization Form.

PARENT RESPONSIBILITIES

The Parent/Guardian agrees to:

- Inform the school of any medical conditions, allergies, or health concerns that may affect participation.
- Provide updated emergency contact information.
- Review and comply with all school policies and procedures.
- Communicate any concerns regarding student safety or participation.

ACKNOWLEDGMENT

By signing below, I acknowledge that I have carefully read and understand this General Liability / Assumption of Risk Agreement. I understand the risks associated with participation in school activities and voluntarily agree to allow my child to participate.

I understand that this agreement remains in effect for the duration of my child's enrollment during the 2026–2027 school year unless revoked in writing and accepted by the school.
